# **Undertaking**

- 1. By submitting the application, the applicant agrees to the Undertaking Statement adjoined with the application.
- 2. The applicant confirms, undertakes and agrees that in the event the applicant's project is selected by NFDC Film Bazaar, the applicant shall not be entitled to release his film based on the said project ("Film") without the following contractual credit acknowledgements:
  - a. NFDC Film Bazaar logo in the credits of the film, poster and all publicity material once finalized. [Appropriate resolution logo will be provided.]
  - b. The following text in opening credit sequence –

"Supported by NFDC Film Bazaar Co-Production Market 2023" Or

"Developed in cooperation with NFDC Film Bazaar Co-Production Market 2023"

Appropriate resolution logos will be sent on request.

Fulfilling this condition is a prerequisite for the project's eventual release on any distribution platform. Failure to do so will attract a penalty of Rs.1,50,000/- (Rupees One Lac Fifty Thousand only).

3. The applicant agrees to hand over a copy of the finished Film (on a hard drive/pen drive) along with one of each publicity material used prior to the release of the film to enable NFDC Film Bazaar to ascertain that the credits and placement of the NFDC Film Bazaar logo is accurate. In the event NFDC Film Bazaar intimates to the Applicant in writing to change the credits or placement of the NFDC Film Bazaar logo, then the applicant shall be bound to carry out such changes. The applicant agrees and understands that NFDC Film Bazaar shall be entitled to seek injunctive reliefs against the Film in the event of the applicant's breach of this obligation to accord NFDC Film Bazaar with appropriate credits as directed by NFDC Film Bazaar.
