Application

Q. What is a MyFilmBazaar Account?

A. MyFilmBazaar Account displays all of the applications made by a single person. Please note that if you want to submit more than one application to the Co-Production Market Web-Series and/or any other Film Bazaar program, you must first create an account. If you have already registered, you will be requested to provide the same login credentials you used when you originally applied.

Q. Can I apply with more than one project?

A. Yes, even though we accept multiple projects from the same director/producer, only one project will be considered for selection.

Q. Is there any special requirement in terms of the subject of the project?

A. The chief criterion for selection in the Co Production Market Web-Series is that it should be an original concept in any Indian language. In case of an adaptation, the producer must have all the necessary rights to the story.

Q. Is the Co-Production Market open for Web-Series?

A. Yes. This is the first time we are accepting applications for series/shows under Co Production Market Web-Series. Kindly check the Film Bazaar website for more details.

Q. Can I apply with a short series idea?

A. Yes, but the series must have a minimum of 4 episodes with an approximate duration of 25-60 minutes per episode. For this edition of the Film Bazaar, we are only accepting fiction projects.

Q. I am a writer/director attached to the project but don't have a producer. Can I apply?

A. No, the Co-Production Market Web-Series is only eligible to projects having a producer attached and at least the main cast and crew of the series soft locked.

Q. Can we apply as an individual or do we need to be associated with a company?

A. Yes, you can apply as an individual. However, being associated with a company adds credibility to a project and thus places the project in a better position when compared to projects that aren't supported by a company/organization. In addition, all international entities - funds, producers, distributors and sales agents require the existence of a legitimate company/organization before they commit any resources. It must be noted that without the existence of a legitimate company/organization commercial, financial and legal paperwork cannot be executed. The company could either be the producer's own company or they could be attached to a line production company.

Q. Can I select more than 1 genre for my project in the application form?

A. Yes, you can select multiple genres/themes for your project. But it is advisable to limit your selection to three important genres that describe your project the best.

Q. Is filling up the contact details for each individual mandatory? Who will be the Primary Contact?

A. It is mandatory to fill out the contact details of every individual Director(s) and Producer(s) so that the Co-Production Market Web-Series team may reach them at any time throughout the Bazaar. It is also required to designate one person as the project's primary contact, whether the Director or the Producer. Please note that Film Bazaar only recognizes the Director(s) and Producer(s) mentioned in the application as the project representatives. Only they are allowed to be present at Co-Production Market Web-Series and feature in the catalog, so repeated contact information will not be accepted. Furthermore, all correspondence about the selection process and guidance via the Bazaar will be with the project's Primary Contact person.

Eligibility

Q. I had submitted the project earlier to the Co-Production Market but it was rejected at the application stage. Can I apply again?

A. Yes.

Q. I was selected last year for the Co-Production Market. Am I eligible to apply again?

A. You may apply again to the Co-Production Market if you have a new project. Projects that have been selected in past editions of NFDC Film Bazaar Co-Production Market may be submitted for consideration. However, please note that preference will be given to fresh titles and projects that have not been previously showcased in our event.

Q. My project has been through another market, can I apply for the Co-Production Market Web-Series at Film Bazaar?

A. Yes, please include in your application, the market(s) that your project has participated in before Film Bazaar 2024.

Q. I have received a seed grant but the principal photography has not yet started. Can I apply for the Co-Production Market Web-Series?

A. Yes. Please specify in the application form.

Q. I have received financial support from a cultural institute instead of a production company, can I also apply?

A. Yes. You are eligible to apply. However, please provide details of the Organisation/Institute/Programme in the application form.

Selection and Timelines

Q. When will the selected projects be announced?

A. The selection for the Co-Production Market will be declared tentatively by mid October 2024.

Q. Can I remove, replace or add another producer to the project after my selection?

A. If any project has a new addition in their team post selection, please write to the CPM Web-Series Team for clarifications and the way forward.

Payment

Q. I made an online payment but I received a failure message at the end. The amount has been debited from my account. What should I do?

A. If the amount was deducted from your account but you received a failure message, please do not proceed with another transaction.

Q. Is the application fee refundable?

A. No, the application fee is non-refundable.

Travel, Accommodation and Accreditation

Q. How many people will receive complimentary accreditation per project?

A. Only one person per project will receive complimentary accreditation for Film Bazaar. Any additional representatives who wish to attend Film Bazaar will have to register themselves on the Film Bazaar website.

Q. Who bears the cost of travel and accommodation?

A. Film Bazaar will only bear the expenses of only one room for accommodation per project in the Co-Production Market Web-Series. The travel cost shall be borne by the applicant. Film Bazaar will not bear the cost of any additional representatives attached to the project.

Q. In case I am selected, when do I need to be present in Film Bazaar, Goa?

A. You would be required to be present in Film Bazaar on/before November 19th as per the intimation that will be mailed to you by the Co-Production Market Web-Series team subsequently

At Co-Production Market Web-Series

Q. Will NFDC help in finding a producer?

A. NFDC only offers an opportunity to the selected participants to attend the Film Bazaar in Goa. It is the participant's responsibility to find funding for their project. However, NFDC does offer assistance in identifying potential partners to the project during Film Bazaar.

Q. What is Open Pitch?

A. Open Pitch takes place tentatively on the morning of November 21, 2024, the first day of the market, where selected participants pitch their projects to an audience of invited industry professionals.

Q. What is Video Pitch?

A. A Video Pitch includes a piece-to-camera wherein the director and/or producer talk about their film project along with visuals (stills/video) which introduce the world of their film to the audience. Please Note - ONLY the selected participants will be required to make a Video Pitch.

Q. Can my producer's representative participate in the Market meetings?

A. No. Only the Producer(s) and/or the Director(s) will be allowed to represent the project.

Q. Can I remove, replace or add another producer to the project after my selection?

A. All changes are required to be communicated to the Co-Production Team.

Q. How many team members can attend the Co-Production Market Web-Series One-to-One meetings at a time?

A. At a time, we can accommodate only two representatives per project at the Co-Production Market Web-Series one-to-one meetings. Film Bazaar recognizes only the Director(s) and Producer(s) mentioned in the application as project representatives who will be allowed to be present at Co-Production Market Web-Series, and feature in the Co-Production Market catalog. Any removal or replacement in the team after selection will disqualify the project. All changes are required to be communicated to the Co-Production Market Web-Series Team.
