

# PRODUCERS' LAB

## RULES & REGULATIONS



Please read the following points carefully to understand the requirements and rules of the Producers' Lab 2016.

### Eligibility Criteria

Anyone who satisfies the below mentioned criteria can apply to the Lab:

- ✓ Applicants should be proficient in English language.
- ✓ Applicants from across the world are allowed to participate.
- ✓ **For Industry Professionals** - Applicants should have worked in the capacity of a Producer or Line/Supervising/Executive Producer on EITHER one of the following and completed the same.  
Feature Film | Documentary Film | Short Film | Television Commercial | TV Serial  
Applicants who have not completed either one of the above but have projects in development or production will not be considered.
- ✓ **For Students** - Applicants should be currently enrolled in an Educational Institution and should be above 18 years of age

### **For Selected Participants only**

1. Industry professional whose application has been selected to participate in the Lab will have to pay a non-refundable participation fee of INR 25,000/-, if application submission was on or before the Regular Deadline, October 15, 2016 (12 am IST).
2. Industry professional whose application has been selected to participate in the Lab will have to pay a non-refundable participation fee of INR 27,000/-, if application submission was on or before the Extended Deadline, October 20, 2016 (6 pm IST).
3. Students whose application has been selected to participate in the Lab will have to pay a non-refundable participation fee of INR 12,500/-, if application submission was on or before the Deadline, October 20, 2016 (6 pm IST).
4. Industry professional who is already a paid registered delegate for Film Bazaar 2016, in addition to Registration fee, needs to pay INR 11,000/- towards Producers' Lab application fees.
5. Student who is already a paid registered delegate for Film Bazaar 2016, in addition to Registration fee, needs to pay INR 5,500/- towards Producers' Lab application fees.
6. Payments can be made via DD or NetBanking/Wire Transfer or Cash only.
7. The participation fee will only include the cost of accreditation at the Bazaar and the cost of participation in the Producers' Lab.
8. The participation fee does not include the cost of travel to & from Goa and accommodation in Goa. The participants will have to facilitate their travel and accommodation themselves.

***Selected participants are required to pitch a project they are currently working on at the end of the Lab as a "deliverable". It will have to be a fiction full-length feature film and can be at any stage of development or production.***
