

## **Market Rules & Guidelines**

**Film Bazaar** is owned and organized by *National Film Development Corporation of India* (NFDC), a corporate entity under the Ministry of Information & Broadcasting, Government of India. Neither Film Bazaar nor NFDC is responsible for the activities, performance or failure to perform of any of the Companies, Participants, Industry Attendees, Sponsors, Affiliates or any other party | person | legal entity who may participate at Film Bazaar or who may otherwise utilize the facilities or services of Film Bazaar or NFDC; nor are they liable for the actions, in-actions or negligence of suppliers, utilities, vendors, screening theaters, hotels, transportation and other facilities and | or parties; nor for major events including without limitation, strikes, work stoppage, war or military activities, civil disorders, criminal conduct of others, weather, fire, earthquakes, acts of God or other events beyond NFDC or Film Bazaar's control.

- All Film Bazaar participants shall indemnify and hold harmless NFDC, its members, officers, directors, employees and agents of each of the foregoing from and against any and all claims, damages and liabilities (including reasonable attorney's fees) relating to or arising out of any breach or alleged breach of their agreements or alleged agreements with third parties.
- All Film Bazaar delegates shall be responsible for their costs and fees associated with participating in Film Bazaar, including but not limited to, all fees associated with registration and participation. In the event of cancellation of registration or non-participation in Film Bazaar following registration, the participant shall not be entitled to a refund of fee paid during registration.

## **Maintaining the Integrity of Film Bazaar**

• As the owner and operator of the Film Bazaar, NFDC has the right in its sole discretion to apply, interpret and revoke the Film Bazaar Market Rules. In the event of such revocation, NFDC shall have the absolute right to prohibit entry to any individual and | or company to Film Bazaar. Also, in such an event, the participant shall not be entitled to a refund or rebate of any fees previously paid to Film Bazaar or NFDC, nor shall Film Bazaar or NFDC be responsible in any way for any of the costs, which the company, or such individuals, may have incurred in connection with preparation for, or attendance at Film Bazaar.

- NFDC reserves the right to revoke previously granted badges and | or prohibit a company, its
  affiliates, all its employees, and | or an individual from participating in a current or future Film
  Bazaar Edition(s) for the following
  - 1. Delegates who breach the safety and security of Film Bazaar, which includes, but is not limited to, threats to other participants, Film Bazaar staff, hotel staff, or any person whatsoever, carrying of weapons, or violations or general security concerns at the Film Bazaar.
  - 2. Delegates who have been convicted of criminal copyright infringements.
  - 3. The legal drinking age set by the Government of Goa is minimum 21 years of age. Underage delegate who are caught drinking or in possession of any alcoholic beverage while attending the event.

## **Badge Restrictions**

- All individuals who wish to gain access to Film Bazaar must have a Film Bazaar badge. Lost or stolen badges must be reported to Security. Reissuing of a new badge will be charged an additional fee of INR 1000 and the new badge will be issued during the Bazaar working hours. Film Bazaar reserves the right to refuse the re-issue of a replacement badge.
- Any person found to have produced, distributed, authorized or in any other way participated in the use of counterfeit badges will be subject to levy of a fine or and will have to undergo necessary legal formalities.

## **Promotional Material**

• Promotional material may not be handed out or left in the hotel hallways, elevator lobbies, bathrooms, or anywhere on the hotel property (Goa Marriott Resort). All such material will be confiscated and/or removed by Security.
