RULES AND REGULATIONS

CO-PRODUCTION MARKET

1. This year, the Co-Production Market will be held online as part of NFDC Film Bazaar Online Nov. 2021.
2. This year Film Bazaar is offering one free registration per film application. Either the director or the producer can avail this free registration to represent the film at NFDC Film Bazaar Online Nov. 2021.
3. This application form is only for submitting the film to the Co-Production Market. This form should not be confused with registration to Film Bazaar. On successful completion of this application, you will be guided on how to register further as a delegate by the Film Bazaar team.
4. The application fees are mentioned in INR and are non-refundable. This fee is inclusive of one free registration to attend NFDC Film Bazaar Online Nov. 2021. An applicant who submits a project but is not selected at the Co-Production Market can still attend Film Bazaar Online Nov 20-25 as a delegate at no additional cost.
5. Only films with South Asian themes are eligible. Else, the filmmaker or at least one of the Co-Producers of the film should be from India / South Asia. In case of an anomaly, please write to coproduction@filmbazaarindia.com for clarification.
6. The Co-Production Market is only eligible to projects having a producer attached and at least 25% of the financing in place.
7. The project is only eligible if the principal photography has not begun.
8. Your application must be submitted in the English language only, regardless of the final language of the film.
9. Applications will be processed only after receipt of the application fee.
10. Shortlisted participants will be asked to send their scripts in the English language (with dialogues, 70 – 100 pages). Shortlisted projects with scripts in regional languages will be required to submit a translated version. The project will not be selected if there is no script.

11. It is mandatory to submit a Video Pitch once the project is selected.
12. All communication will be directed only to the primary contact person as reflected on the application form. Once the application procedure is complete, NFDC Film Bazaar may ask for additional project information, if needed. Kindly ensure that the primary contact person is available to respond to emails promptly.
13. For the duration of the market, either the Producer or the Director of the project must be present online.
14. A virtual orientation session is held a few days before the Bazaar to familiarise attendees with the Co-Production Market's operations. Participation of project representatives is mandatory at the session.
15. Submission of multiple projects at the same time is acceptable. However, only one project per Director or Producer is selected.
16. Only the Director(s) and Producer(s) specified on the application form will be considered project representatives and are eligible to attend the online Co-Production Market and be included in the e-catalogue. Once the project is selected, you cannot remove or replace a project representative (director/producer) as that will lead to the disqualification of the project. However, If any project has a new addition in their team post selection, please write to the CPM Team for clarifications and the way forward.
17. The maximum number of representatives per project who can attend online meetings is limited to 2. If the project representatives are more than 2, attendees will be limited to 3 members.
18. The information on the application form cannot be edited once submitted.
19. Rights of admission reserved.
20. The decision of NFDC Film Bazaar regarding the selection of an application is final and binding.
21. NFDC Film Bazaar reserves the right to invite a project.
22. NFDC Film Bazaar reserves the right to change the Terms & Conditions of the programs without prior intimation.
