

Following are the rules and regulations pertaining to the Industry Screenings at Film Bazaar Online. Please read the following points carefully to understand the requirements, rules and constraints of the program.

1. A Film Bazaar Delegate Registration is mandatory to book an Industry screening.
2. The films can be of any length and genre (Feature Film, Short Film or Documentaries).
3. This year Industry Screening will be held online as part of NFDC Film Bazaar Online.
4. The screenings are purely for purposes of trade and are not in the nature of public exhibition.
5. The Film Bazaar is not responsible for the audience attendance at the Industry Screenings.
6. For the applicants of Industry Screening, at the time of submitting their film, they will be expected to sign the following Undertaking.
7. A filmmaker cannot use the logo of NFDC Film Bazaar in their film or promotional material without permission of NFDC. A film in NFDC Film Bazaar does not indicate that NFDC endorses the film in any way.
8. The application fees are in INR and non-refundable. There is a different fee for Delegate registration and Industry Screening booking.
9. Once the application procedure is complete, NFDC Film Bazaar may ask for additional project information, if needed.
10. The Film Bazaar has the right to reject the film if guidelines and regulations are not adhered to and/or submissions are incomplete/ in wrong format/ past due date or any other reason specific to the film submitted. The decision of the Film Bazaar team is final.

### **APPLICATION FORM**

1. The email address and phone number provided by the primary contact person in the application form shall be regarded as the single-point contact address between NFDC Film Bazaar and the applicant. Kindly ensure that the primary contact person is reachable at all times till the end of NFDC Film Bazaar Online.
2. The contact details of the first producer mentioned on the application form will be published in our Online catalogue. Hence, please ensure that this belongs to the rights holder of the film who would be able to respond to potential future queries by international film professionals.
3. Word limits are to be adhered to wherever mentioned in the application form. NFDC Film Bazaar reserves the right to shorten and/or edit the text for the purpose of publication of selected projects in the NFDC Film Bazaar Catalogue.
4. Completed applications need to be submitted by the prescribed deadline. NFDC Film Bazaar will not take the responsibility for the exclusion of projects if complete information is not supplied by the above-mentioned date.

5. The filmmakers are required to submit at least three film-stills and one director's photograph along with the application form. These should be three images from the film and not production/working stills. NFDC Film Bazaar reserves the right to crop the images as per design requirements.

6. Application will be considered complete only upon payment of the mandatory application fee.

7. By submitting the application form for Industry Screening the applicant hereby certifies, with regards to all third parties involved, that he/she has read and understood the rules and regulations listed, that he/she is legally authorized to submit the film for Industry Screening and that the information given by the applicant is true and correct. The applicant indemnifies Film Bazaar and NFDC against any claims to the contrary.

Your application will not be considered complete without the following payment:

- Industry Screenings fee of INR 3,000 per screening
- Submissions received after the deadline will not be accepted.
- The fees can be paid through Net Banking, Credit/Debit Card or UPI.

### **Technical Specifications**

- File size should not exceed 8 GB.
- The Frame rate should be 24 or 25 frames per second.
- Size / aspect ratio: 1920 x 1080 px / 16:9 HD.
- Video codec / bit rate: H.264 high profile / 10.000 Kbit/s
- Audio codec / bit rate: AAC / 320 Kbit/s, sampling rate 48 kHz.
- Please submit an English subtitled version (except if the film's original version is English).
- Audio, video and subtitles must be contained in a single file.
- Please submit HD material in the mp4 format (H.264, AAC, Stereo).
- The file name must be in English and must not include any special characters or blank spaces.
- The file should not have a watermark as the NFDC Film Bazaar watermark will interfere with the image.
