## Student Delegates Registration FAQ's

### **Q. What is *MyFilmBazaar* account?**

*MyFilmBazaar* account allows you to –

- Register for Film Bazaar
- Save draft submissions, review, and make changes to your profile
- Apply to various Film Bazaar programmes
- Log in to complete and submit your application
- View completed submission forms
- Access to the virtual platform of NFDC Film Bazaar Online

### **Q. How and when can I register as a delegate at Film Bazaar Online?**

You can register as a delegate at Film Bazaar by filling out an online application form. Go to the "[Sign Up](#)" section of the [website](#) and create a *MyFilmBazaar* account.

The dates/deadlines for Delegate Registration are announced on the [website](#).

### **Q. What does "passport-sized photo" mean?**

It means your photograph must be: 2x2 inches in size, recently taken, in colour, front profile, .jpg format.

### **Q. Do I have to pay for Registration (also referred to as Accreditation)?**

You can create an account on our website for free. However, you have to pay for Registration to attend the Film Bazaar. Registration to attend Film Bazaar is confirmed once we receive the payment.

**Q. What is the registration fee for Film Bazaar Online?**

Early Bird Registration	September 18 <sup>th</sup> to October 31 <sup>st</sup> , 2021, (11:59 PM IST)	INR 5500
Regular Registration	November 1 <sup>st</sup> to November 25 <sup>th</sup> , 2021, (11:59 PM IST)	INR 7000
Student Registration	September 18 <sup>th</sup> Onwards	INR 2500

**Q. Is the application fee refundable?**

No. The application fee is non-refundable and non-transferable.

**Q. I want to register for the Film Bazaar Online, what are the requirements?**

If you want to register as -

- a) **Industry Delegate** - upload a current passport-sized photo, a short profile and if you are representing a company, upload the company logo.
- b) **Student** - upload a current passport-sized photo, a scan of valid photo ID, a government verified age proof, and a letter granting permission to attend the Bazaar signed and stamped by the college authorities on college letterhead.

**Q. I have registered for Film Bazaar Online, what do I get access for?**

- Access to the Knowledge Series
- Access to the Film Offices
- Access to the Filmmaker's Pitches
- Profile in the Film Bazaar Market Guide
- Access to the Film Bazaar Market Guide
- One Year Subscription to *MyFilmBazaar* Account (valid till October 31, 2022)

(Note: Registered Students will not be featured in **Online** Market Guide)

**Q. I have registered as a delegate but have not received a confirmation email. Should I be concerned?**

If you don't hear from us within 2 days of making a payment, please write to us at [registration@filmbazaarindia.com](mailto:registration@filmbazaarindia.com).

**Q. Will I receive a receipt/invoice for my registration fee?**

Yes. Once registration is complete, delegates can view and print their payment receipts from their *MyFilmBazaar* account. Also, a copy of the same will be mailed to your registered email-id.

**Q. I have made a mistake while filling the registration form. What should I do?**

In case of any mistake that needs to be corrected post submission of Registration Form, please DO NOT start a new application. Please get in touch with the team and send the corrections to [registration@filmbazaarindia.com](mailto:registration@filmbazaarindia.com).

**Q. How do I know if I have access to the Viewing Room?**

Viewing Room (VR) has restricted entry and allows only buyers, world sales agents, distributors, film festival directors/programmers, and representatives of digital platforms dealing with acquisitions to watch films from the VR Library. If you wish to know before the Film Bazaar whether you have access to the Viewing Room, you can write to [films@filmbazaarindia.com](mailto:films@filmbazaarindia.com) after you have registered successfully.

**Q. If I've submitted my project to one of the labs, do I have to pay for the registration?**

If you have submitted a project to any of the labs, Co-Production Market, Work-in-Progress Lab or you have submitted a film in the Viewing Room, you will get one complimentary accreditation to attend Film Bazaar online as an industry delegate.

Please note that the delegate registration process is separate from your project submission process. To attend NFDC FilmBazaar Online, please log in to your [myfilmbazaar](#) account and register through the My Film Bazaar welcome page. You can also register as a delegate here -- [Attend as Delegate](#).

For queries related to specific programmes please visit the website.

**Q. What is the payment process?**

Once you have filled in all required information in your online application form, you will be directed to a payment page where you can choose Credit/Debit Card or Netbanking or UPI.

**Q. I have made the payment using Net Banking /UPI and there was a failure message. The amount has been debited from my account. What should I do?**

In case the amount has been debited from your account, but you have received a failure message, kindly do not make another transaction. Write to us at [registration@filmbazaarindia.com](mailto:registration@filmbazaarindia.com) so that the Film Bazaar Team can guide you further.

**Q. I began the online registration process and left the form halfway. I now want to go back and complete my form/registration for Film Bazaar 2020. How do I do this?**

To complete an incomplete Application/Registration you need to 'Login to your

*MyFilmBazaar* Account' by entering your username and password. On a successful login, you shall be directed to your *MyFilmBazaar* account page where you can select the relevant Application and complete your Registration. Please DO NOT start a new application.

**Q. I attended Film Bazaar last year and received a username and password. Can I still use it for Film Bazaar Online?**

Yes, you can use your old username and password to login. However, you need to register as a Delegate for Film Bazaar to access any information specific to the current edition of Film Bazaar Online.

**Q. I am already registered for the current edition of Film Bazaar Online. A colleague from my company wants to join as well under the same company head. How can he/she apply?**

Your colleague will have to register independently on our website and follow the same procedure that you followed for Delegate Registration. Once your colleague makes the payment and Registration is confirmed, he/she will automatically get listed under the same company.

**Q. I am unable to attend. Can I transfer my Delegate access to a colleague or receive a refund?**

No. All registrations to Film Bazaar Online are for an individual, non-transferable, and non-refundable under any circumstances including non-participation.

**Q. A couple of my colleagues from my company want to attend. Can I share my online access with my colleagues?**

Online Delegate access is for registered users only. Only one user can log in and access Film Bazaar Online. Each employee representing a company will have to register separately to get access.

**Q. I want to attend Film Bazaar Online only for a day or two. Will I still have to pay the entire registration fee?**

Yes. Film Bazaar gives opportunities for filmmakers, producers, students, other film industry professionals and the likes to connect and network as much as they can over the course of 6 days. Registration has to be done for the entire event. There are no daily passes available.

## **Attending Film Bazaar Online**

**Q. How do I access the Film Bazaar Online platform?**

Film Bazaar Online is accessible through the myfilmbazaar online account of all

registered delegates. Simply login to your account and enter the platform through the Film Bazaar Online Portal button.

**Q. Do I get a Delegate Kit for registering on Film Bazaar Online?**

Yes. All registered delegates will get an online Delegate Kit with the Pdfs of the Market Guide, Viewing Room/ Work in Progress Catalogue, and the Co-Production Market Catalogue.

**Q. How do I navigate through the Film Bazaar Online Platform?**

For your ease of use, we suggest you update your browser to its latest version. The Film Bazaar Online interface has a simple point and click navigation with 360-degree maneuverability. You can just click on the edges of the screen to move left or right and click on the various virtual locations on the screen to access them. A demo video explaining the navigation is available at the entrance of the virtual platform to aid novice users.

**Q. I am facing certain technical issues using the Film Bazaar Online Platform. Who do I contact?**
