## Rules and Regulations

The National Film Development Corporation Ltd is responsible for the organization of International Film Festival of India (IFFI) and Film Bazaar. The aim of the market is to enable Countries, States, Film industry Entities and Film Professionals to promote their Locations/ Infrastructure/ Professional Services/ Equipment/ Studio Setups/ OTT Platforms and make valuable business contracts at Film Bazaar. The market aims to facilitate international collaborations across the globe.

Pavilion Rental is ideal for Countries, States, Film industry Entities and Film Professionals whose core activities are listed below -

- Countries and States whose locations are suitable and being offered as shoot locations to film makers across the globe.
- Countries/ States/ Companies whose main activity is production, distribution, exploitation or international broadcasting of cinema across various formats of screenings.
- Companies providing films and TV related professional services/ equipment on hire or sale / locations and infrastructure on hire.
- Institution, association and professional organization whose main work is in relation with the film industry.

Accompanying registration for the above listed potential participants at the Pavilions in Film Bazaar is strictly for employees and / or executives of the respective Countries/ States/ Companies participating at the Pavilions.

The conditions and schedules of payment are detailed in the pavilion rental contract. All payments must be made by Bank Transfer(NEFT/RTGS/IMPS).

### **PRESENCE OF THE PARTICIPANT – PAVILION ACTIVITY**

The Film Bazaar will be held from November 20 – 24, 2022 and the Market officially begins on the 21st of November. Minimum one participant registered by the Company must be present in his/her pavilion and keep it active and equipped from (9am – 6pm) for the entire duration of the market.

1. The Participant of each pavilion agrees to familiarize himself/herself with and to accept, without reservation, all the regulations issued by the administration of Film Bazaar and in particular with regard to safety regulations, conveyed to the company in the rental contract

### RESPONSIBILITY

NFDC Film Bazaar are released from all responsibility in the event of damages, theft and loss of belongings of any participant at the Pavilion Zone.

### TERMS OF CANCELLATION

1. In the event of cancellation of said event, payment made upon signature of the contract, will be reimbursed.
2. In the event of cancellation of a booked pavilion before Nov 1, 2022, 20% of the fees paid will be deducted.
3. Any cancellations of a booked pavilion from Nov 1, 2022 to Nov 10, 2022, 50% of the fees paid shall be deducted.
4. Any cancellations of a booked pavilion post Nov 10, 2022, no refund shall be applicable.

Any form of advertising other than that using the media made available to the participants by the organizer, and for which the fees for insertion or display have been paid beforehand in accordance with the rates in force, is strictly forbidden unless pre-intimated and pre-approved by authorized personnel of Film Bazaar. Any additions in terms of furniture and fixture can be directly dealt with the official vendor at actuals.

Any authorized advertorial-type advertisement within the event venue must carry the banner "Publicity" (ADVERTISEMENT). For example, the use of self-adhesive advertisements or advertising materials not specially authorized by the organizer is strictly forbidden. Furthermore, the distribution of prospectuses, brochures, leaflets or documents of any kind as a promotional item is strictly limited within the applicable IFFI and Film Bazaar venue and its subject to the Organizer's prior permission.

The Organizer shall have the right to use the images of various collaterals in the pavilion for publicity a well for media campaigns, both paid and unpaid widely on social media and electronic media. The participants shall also support the event in this endeavor.
